This plan has been submitted to both DEP and EPA for their review and consideration. The plan can be viewed on our website at www.scrantonsewer.org. A copy will be available at the Scranton Public Library. Also, as a friendly reminder, please do not use your corner catch basins as a place to deposit your leaves. This practice blocks the catch basins and leaves reaching the Treatment Plant harms the treatment process.
