The Project includes construction of a small building addition, approximately 13,800 square feet of office renovations, new access ramps, fences and gates and parking lot improvements located at 1360 Wyoming Avenue in the City of Scranton. The County reserves the right to award some or all of the contracts, and to cancel and to reject some or all of the bids.

Bid envelopes to be plainly marked with the name and the number of the contract for which the bid is intended. All bids must be received by the Lackawanna County Controller, 123 Wyoming Avenue, 2nd Floor, Controllers Office, Lackawanna County Government Center at the Globe, Scranton, PA, 18503 not later than 11:00 A.M., Thursday, October 17, 2019 by Order of the Lackawanna County Commissioners. Bids will be publicly opened and read aloud at 2:00 P.M.

Bidding Documents are on file and available to bidders on CD on or after Wednesday, September 11, 2019. Bidding Documents may be obtained from Greenman-Pedersen, Inc. (GPI) at 52 Glenmaura National Boulevard, Suite 302, Scranton, PA between 9 am and 4 pm upon payment of a non-refundable fee of \$25.00 payable to Greenman-Pedersen, Inc. A bid guaranty, a certified check, bank cashier's check, trust company treasurer's check, bid bond on the form provided and furnished with the Contract Documents, or other form of security permitted by applicable law in the amount of 10% of the Total Bid shall be submitted with each proposal as a guarantee that the bidder will execute the contract if awarded the same. Checks to be made to the Treasurer of Lackawanna County.

The Project for which construction bids are being solicited hereby is a project constituting public works. The Contract Documents specify the payment of Pennsylvania prevailing wage rates for the Project and are attached to the Bidding Documents. The wage rates will also be posted in a conspicuous location, visible to all of the contractor's employees.

A mandatory Pre-Bid will be held at the location of the Project Site, 1360 Wyoming Avenue; Scranton, PA , on Tuesday, October 1, 2019 at 10:00 A.M. Bids will not be accepted from any bidders who do not attend the mandatory Pre-Bid.

The right to reject any and all bids is hereby reserved by Lackawanna County.
